## **Local Information Network Communications System (LINCS) Health Alert Network...**

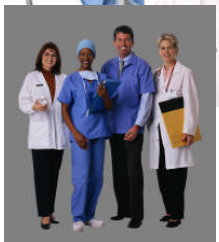


is a **no-cost statewide public health emergency notification system** that links together local, state and federal partners to protect communities from both man-made and naturally occurring disasters
