rulemaking, now that's refreshing!

overnor Christie's first executive order issued upon taking office in January 2010 set the tone for his administration. It put a 90 day freeze on proposed regulations and rules. Since then, efforts to reduce regulations that are unduly burdensome to the State's economy have become a hallmark of his administration. In fact, the New Jersey Register, in which proposed and adopted rules are published, is now markedly thinner than during previous administrations.

The Governor's second executive order established "Common Sense Principles" for State rules and regulations. In part, it directed State agencies to solicit input from stakeholders in advance of any rule-making to "prevent unworkable, overly-proscriptive or illadvised rules from being adopted." HCANJ had the opportunity recently to participate in two stakeholder meetings.

Redevelopers of Bell Labs in Holmdel Seeking Long Term Care Providers as Owner/Tenants

ong term care providers interested in locating a facility in central New Jersey have an opportunity to establish a presence in one of the greatest buildings in the state. Bell Labs, the iconic birthplace of the transistor and the cell phone is being transformed into "Bell Works," a new "town center" in Holmdel, Monmouth County. The two million square-foot Eero Saarinen-designed building, situated on a bucolic campus of 470 acres, is being redeveloped into a six-level mixed use project that will include a 200-room full service hotel and conference center, an indoor/outdoor sports complex, 650,000 square feet of office space, 50,000 square feet of retail, service and restaurant space and over 200 luxury homes to be built by Toll Brothers. Somerset Development (www.sdnj.com), the master developer, is investing over \$100 million in the venture.

The site offers over 4,000 parking spaces and easy access to the Garden State Parkway, Routes 34 and 35, the PNC Center and several hospitals and shopping centers.

Healthcare providers should note that approximately 25 percent of the complex, or about 400,000 square feet, will be developed as a multi-specialty medical center by Community Healthcare Associates (www.cha-properties.com), the redevelopers of Barnert and Greenville Hospitals, as well as the Kessler Hammonton facility. Plans call for a health and fitness center, an ambulatory surgery center, urgent care, a renal dialysis facility, physician offices, sub-

acute care, and a variety of outpatient services such as physical rehabilitation, imaging and sleep centers. The developers also expect that a major hospital system will establish a presence at the site.

Community Healthcare Associates would welcome inquiries from operators of assisted living facilities, adult medical day care, home health agencies, memory care and other providers of long-term care. Space is available in a wide range of sizes and configurations. Occupancy is expected in the latter half of 2015.

Clinical Corner

IMPACT ACT

The *Improving Medicare Post-Acute Care Transformation (IMPACT) Act of 2014*, which is designed to standardize data used across post-acute care (PAC) settings, enabling payments and patient outcomes to be compared across skilled nursing facilities, home health agencies, inpatient rehabilitation facilities, long-term care hospitals and other providers now awaits the president's signature.

"This bill is about transparency in the areas of cost and quality, providing consumers and government-critical information regarding outcomes and cost. We are very pleased with this outcome," Mark Parkinson, president of the American Health Care Association/National Center for Assisted Living (AHCA/NCAL), said in a statement.

IMPACT, also known as HR 4994, will standardize assessments for critical care issues in areas such as functional outcomes, pressure ulcers and dementia, enabling the development and public reporting of quality measures for providers. It also requires the Medicare Payment Advisory Commission (MedPAC) to provide Congress with new models for PAC payments, including bundled and site-neutral payments.

The legislation eliminates "the silo-focused approach to quality measurement and resource utilization," said AHCA/NCAL Senior Vice President of Government Affairs, Clifton J. Porter II.

Consistent and comparable data collection on patient assessment and outcomes is key to this outcome and, along with patient-centered PAC bundling, holds great promise in reducing costs and improving outcomes for the sustainable preservation of the Medicare program.

Hospice and Palliative Care organizations also support the IMPACT Bill. The legislation requires more frequent surveys of hospice providers, a measure that hospice organizations have championed for more than a decade. The bill mandates that all Medicare-certified hospices be surveyed every three years for at least the next 10 years.

"More consistent surveys, and the process providers go through to prepare for them, will help hospices and ultimately benefit the patients and families in their care."

The new legislation also will facilitate medical reviews for select hospice programs, with a soon-to-be-determined percentage/number of patients/residents receiving care for more than 180 days. The specific patient load that would trigger this medical review is yet to be set by the Centers for Medicare & Medicaid Services. Such a medical review of what are known as "long-stay" patients/residents will help ensure that hospices are appropriately caring for individuals with life-limiting illnesses that are often more difficult to prognosticate than in the earlier days of hospice provision when most patients/residents had a cancer diagnoses, according to the organization, which says that it has supported this provision.

ICD-10 Compliance Date Is Oct. 1, 2015

Reminder: the U.S. Department of Health and Human Services (HHS) issued a rule finalizing Oct. 1, 2015 as the new compliance date for health care providers, health plans, and health care clearinghouses to transition to ICD-10, the tenth revision of the International Classification of Diseases. This deadline allows providers, insurance companies and others in the health care industry time to ramp up their operations to ensure their systems and business processes are ready to go on Oct. 1, 2015.

The rule requires the use of ICD-10 beginning October 1, 2015. The rule will also require HIPAA covered entities to continue to use ICD-9-CM through September 30, 2015.

The first involved draft revisions to the rules, N.J.A.C. 8:85, that establish standards for the provision of nursing services by nursing facilities, providing for the reimbursement of nursing facility services, and setting forth criteria and a process for determining Medicaid eligibility for nursing facility level of care. The other addressed a draft notice of proposal to amend the rules that regulate the Office of the Ombudsman for the Institutionalized Elderly, N.J.A.C. 15A:3. Both meetings provided a most welcomed opportunity to provide input on these regulations before they are formally proposed for readoption.

For example, the draft long term care rules eliminated the current 24-day annual limit on unpaid therapeutic leave days. They also did not reference what role Medicaid managed care organizations would have in the annual assessment of residents' clinical eligibility for nursing facility level of care nor did they specify that the MCO should pay for nursing facility services until it implements a discharge plan for residents who no longer need these services.

The draft Ombudsman rules were essentially an update, changing, for example, the term Ombudsman to Ombudsperson, and recognizing the role of managed care organizations in long term care settings. They also reflected the use of Physicians Orders for Life Sustaining Treatment (POLST) in the chapter that addresses withholding or withdrawing life-sustaining treatment.

Gathering input from stakeholders before rules are proposed for adoption or readoption should help cut down on the need for adverse comments when the rules are finally proposed and, hopefully, lead to a more reasonable end-product. Refreshing!
