This nationally recognized program has three award levels Bronze, Silver and Gold. The Bronze Award is the first step in the Quality Award journey.

The benefits of participating go beyond receiving a quality award. Participation can improve operations and demonstrate your community's commitment to delivering quality care and services. AHCA and NCAL have observed that quality award recipients have clearer priorities, better quality measures, improved staff retention, and reduced staff turnover.

There are resources that make it easy for providers to complete the application process on the quality website. The application packet includes instructions, the Bronze criteria and the application format.

MLTSS Update

As discussed in numerous issues of *Perspectives*, the Managed Long Term Supports and Services waiver is still awaiting final approval from CMS. The scheduled launch date remains January 2013 however, that date seems less likely with each passing week as many questions remain unresolved, including the issues of credentialing, any willing provider, and billing.

HCANJ continues to ask the necessary questions, the answers to which are crucial to the smooth transition to managed Medicaid for recipients and providers alike.
