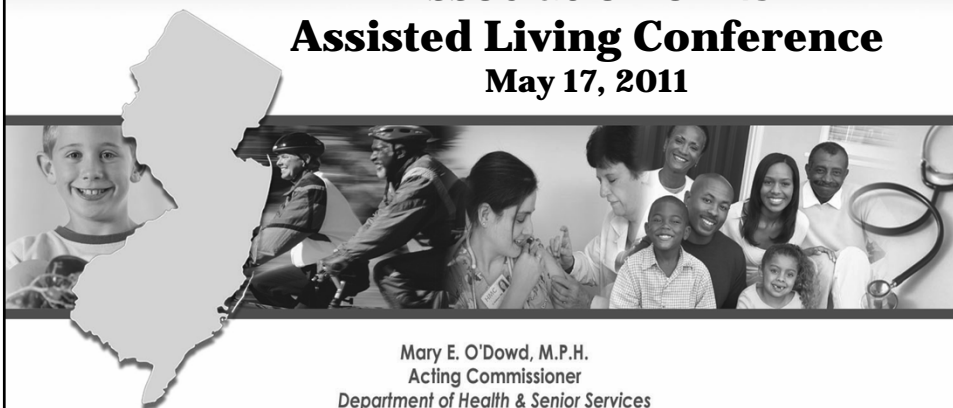

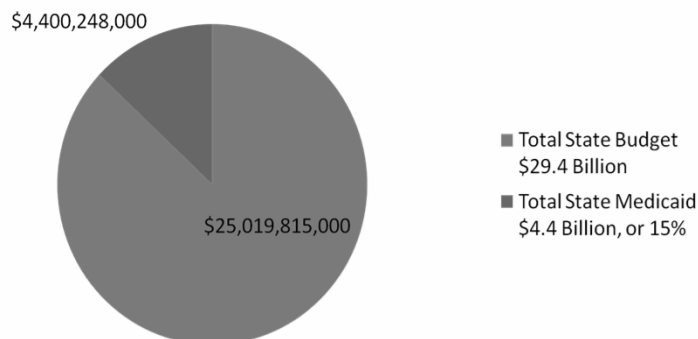

FY 2012 Total State Budget



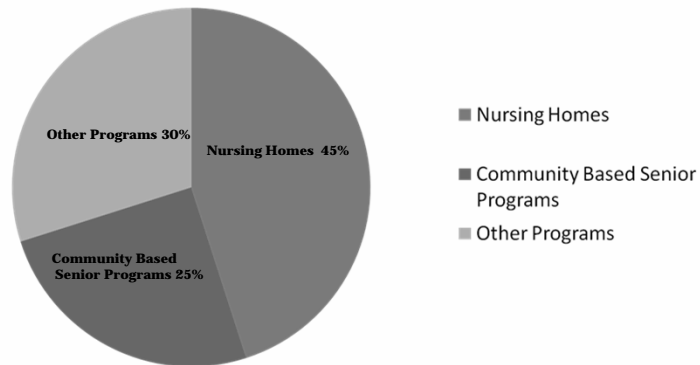

FY 2012 Total State Funding \$1,269,473,000

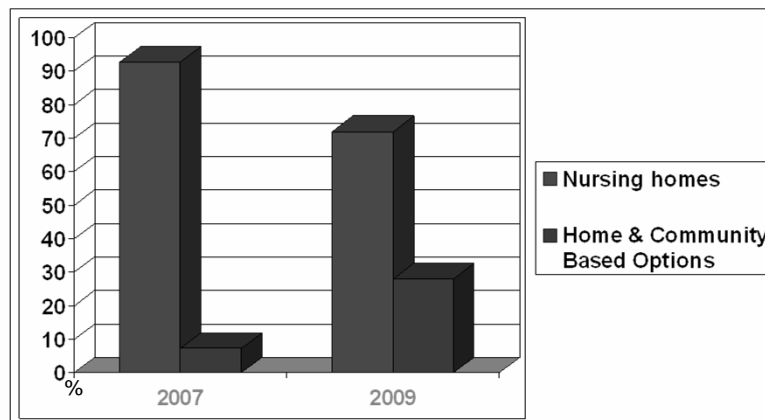

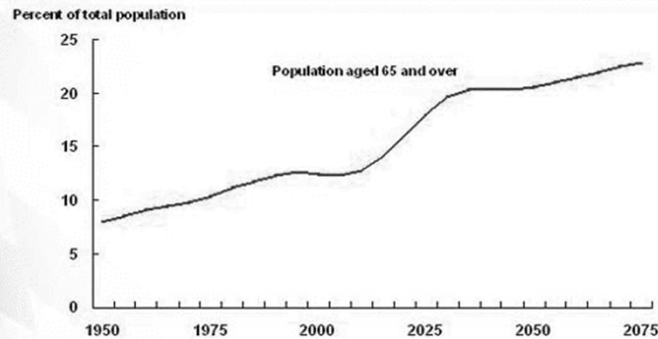
