ABOUT THE VIRTUAL TRAINING

This course has been designed to allow for individuals to attend at a time most convenient for them. It will assist center trainers/instructors in preparing selected, qualified personal care assistants (PCAs) nurse aides (NA) & homemaker home health aides (HHA) for the responsibility of administering medications when a registered professional nurse delegates this task.

The CMA course, not to be confused with this *Train the Trainer Workshop*, prepares personal care assistants, homemaker home health aides and nurse aides to administer medications in assisted living residences and comprehensive personal care homes or assisted living programs.

All RNs working in assisted living that have the CMA program **MUST** attend this course and renew their certificate of attendance every five years.

TOPICS TO BE COVERED

- State regulation N.J.A.C. 8:36 subchapter 9 & 11 and Board of Nursing N.J.A.C. 13:37-6.2 regulations
- Board of Pharmacy requirements
- Preparing to function effectively in administering medications
- Administering and assisting residents with self-administration of medication, prepared instillations, treatments and insulin injection
- Eligibility for certification as a CMA and maintaining certification
- Understanding the role of the registered pharmacist in providing consultation / collaboration
- Understanding your role as the trainer / instructor
- Developing a monitoring system to ensure ongoing compliance with regulations
