HCANJ Convention & Expo Rules and Regulations for Attendees

By submitting a facility registration form and paying the appropriate fees to attend the HCANJ Annual Convention and Expo, you agree to all terms written below and to honor the rules and regulations of the show.

REGISTRATION POLICY:

- ⇒ Registration is **PER FACILITY, NOT PER INDIVIDUAL**.
- ⇒ 14 max attendees per facility.
- ⇒ Attendees must be employed by the facility that is registering them.
- ⇒ Consultants or contracted vendors are not eligible to be registered with a facility.
- ⇒ In order to register, the facility must include the complete facility badge registration form listing the names of their employees, what CEs they are looking to earn (checking all that apply) and their individual email address.
- ⇒ Companies that own and/or manage more than one facility MAY NOT register all facilities under their company name.
- ⇒ Corporate offices must register independently using the facility registration form and pay the facility registration fee as indicated on the form.
- ⇒ Registration will not be accepted without the completed facility registration form and payment in full.

INFRACTION POLICY:

REGISTRATION PACKETS & BADGES:

- ⇒ Registration includes unlimited access to all educational programs during the convention, and daily exhibit ballroom activities.
- ⇒ Registration badges may be picked up at the HCANJ Registration Desk.
 - Valid Drivers License or Government ID may be requested when picking up your badge.
- ⇒ If it is found that a badge is used by anyone other than the registered individual whose name appears on the badge, it will be confiscated and made unavailable for use by anyone for the duration of the convention, including the person whose name is on the badge.
- ⇒ No one will be allowed entrance to HCANJ functions without a proper badge.

PRIZE DRAWINGS:

- ⇒ Attendees must be registered with a healthcare facility in order to be eligible to win daily prizes.
- ⇒ The "Passports to Prizes," which are included with your badge must be completed correctly and placed in the prize drawing drum in order to be eligible.
 - Individuals must be present in order to claim a prize.
 - No one else may claim a prize for a winner who is not present.
