### **Rule Adoptions**

The Division of Medical Assistance and Health Services readopted without change the Administration Manual chapter, N.J.A.C. 10:49, which was set to expire on January 7, 2016. The Administration Manual contains general and specific information about the regular Medicaid program, special Medicaid services, the NJ FamilyCare program and other special State funded programs.

Notice of this adoption appears in the February 1, 2016 *New Jersey Register* at 48 N.J.R. 207(a).

The readoption took effect January 7, 2016 and expires on January 7, 2023.

## Rule Proposals

The Department of Human Services, Division of Aging Services, Office of State Health Insurance for the Aged and Disabled and Facilities Management proposes to readopt with amendments the Pharmaceutical Assistance to the Aged and Disabled Eligibility Manual, N.J.A.C. 10:167.

Specifically, the Department proposes to amend several definitions, make changes to reflect an organizational change involving PAAD, to reference the current Appropriations Act and reflect a change in the renewal application process as well several technical changes.

Notice of this proposal, PRN 2016-011, appears in the January 19, 2016 *New Jersey Register* at 48 N.J.R. 105(a). Persons wishing to submit comments on the proposal must submit them electronically to the Division of Aging Services by March 19, 2016.
