Steven will review CMS' Five-Star ratings and how to calculate each domain score, create Five-Star strategies to improve ratings with respect to COVID-19, and identify common research related to Five-Star and COVID.

On April 12, 2019, Governor Phil Murphy signed the "Medical Aid in Dying for the Terminally Ill Act" (the "Act") into law. The Act affirms the rights of qualified terminally ill patients to obtain and self-administer medication to bring about their own humane and dignified death. The Act imposes certain strict obligations upon physicians and facilities that choose to aid patients/residents in exercising their rights under it. This presentation will introduce the Act and its history, detail the obligations of physicians and facilities under the Act, describe the process for carrying out a patient's/resident's wishes under the Act and discuss its legal and moral implications.

This presentation will review diagnosis coding for the pandemic, isolation requirements and coding, and RAI User's Manual in relation to isolation.

### SURVIVING MEDICARE and HMO AUDITS: Practical Strategies in Managing the SNF Revenue Cycle (90 minutes)

Since CMS ended the suspension of Medicare FFS audits (due to the COVID-19 pandemic), providers have been inundated with Medical Review of Claims by Medicare Auditing entities (RACs, CERTs, MACs, SMRCs, etc.) and Medicare HMOs. Under CMS' directive, all audits are being conducted in accordance with statutory and regulatory provisions; ICD-10-CM Coding, MDS 3.0 Coding & Billing requirements, and the appropriate utilization of the 1135 Waivers if applicable. It is imperative for Operators, Administrators, Clinicians & Billers to understand the Claims & Medical Review Process under PDPM and avoid or mitigate denials, recoveries and further scrutiny. We will examine CMS' Program Integrity Strategy, the different types of audits, and the 1135 Waivers, review common reasons for denials and recoveries, and explore strategies to promote "positive audit outcomes" to ensure your center's fiscal survival & viability.
